## **GENERAL INFORMATION**

HUMIC 12% is a proprietary liquid comprised of extracted humic acids and can be applied to most crops. HUMIC 12% may aid in the uptake of micronutrients.

## **DIRECTIONS FOR USE**

FOLIAR: Apply 1 quart – 3 gallons per acre, per application with sufficient water for thorough coverage by ground or air application.

**SOIL:** Apply **2 guart – 4 gallons** per acre, per application with fertilizer or with water. Repeated applications may be beneficial.

## **PROPER MIXING PROCEDURE**

**1.** Fill the mixing tank halfway with water.

**2.** Add HUMIC 12% to mix tank prior to pesticides and most adjuvants at the desired rate.

## COMPATIBILITY

HUMIC 12% is compatible with most liquid fertilizer solutions and pesticide tank mixes. Please refer to the pesticide manufacturer's label for further details. Always jar test combinations to reduce risk of incompatibility. When possible, add HUMIC 12% to the tank first, then add additional fertilizer solutions before mixing thoroughly. When combined with agua ammonia, use mixing and application equipment that are vented and/or have pressure release valves. Do not mix HUMIC 12% with calcium nitrate, phosphoric acid, zinc sulfate or solutions with pH 6.5 or below.
